With this award, the Senegalese sociologist Dr. Fatou Sow – based at the Cheikh Anta Diop University in Dakar and the Centre National de la Recherche Scientifique (CNRS) in Paris – is recognised for her unwavering commitment to the cause of women and her outstanding scholarly achievements in feminist topics on the



African continent. Sow is a veritable pioneer of gender studies and African feminism, who has worked at the forefront of women's rights in West Africa and beyond for more than half a century. Two Junior Fellow Representatives, Ngozi Edeagu and Monika Rohmer, enriched the evening with their humorous moderation. Emiliano Minerba defended his dissertation with the title "Historical-comparative analysis of the Swahili and Wolof metrical systems" on May 20th.


Dikko Muhammad defended his dissertation with the title "Dispersal of Discourses in the Poetry by Women in Northern Nigeria" on June 13th.
